Bullet Points from the Conference call concerning the Statute Changes:

Grant: The goal today to ideally review all the changes and vote on them as a Board or to schedule another phone meeting in the next week to vote on the changes.

Max: page by page changes

Page 1	Fingerprinting and fingerprinting checking. Should it be in the Board Statute or each Profession's Statute?
Page 2	Section 2A. Professional Counselor Statutes new language with reciprocity, "Registration, certification, or licensure to practice professional counseling <u>for at least 60 of the last 66 months immediately preceding the application</u> "...
Page 3	Addition of " <u>If required by the Board</u> ", the Board shall fix by rule and regulation...
Page 4	Section 9, that which was stricken, needs to be kept (was stricken inadvertently)
Page 5	Stricken language, new language on Page 6
Page 7	Administrative proceedings, Section 8b in the underline. If we have that, then we don't need section 5 (can be repealed)
Page 7 & 8	Start Social work profession, Page 8 – 2A Reciprocity language, " <u>for at least 60 of the last 66 months</u> "
Page 9	At the top Section d "shall pay and application fee" will insert " <u>If required by the Board</u> ", shall pay...
Page 9	Sections "g, h, & i" should NOT be stricken, these sections need to stay
Page 10	Section "j" needs to be kept. Section "k" is stricken because now everyone is KAPA and they will be notified, it is just a different process in KAPA. Bottom of page 10, standard language concerning issue, renew or reinstatement will be used.
Page 11	Standard language for revoking a license
Page 12	Administrative Proceedings shall be conducted in accordance with KAPA
Page 13	As part of the applicant's "approved" social work degree program... Bottom of page 13, Section 1, insert language. "if required by the Board", shall be not more than...
Page 14	No language concerning replacement of a wallet card. Want to insert language, "replacement of a wallet card shall be no more than \$5"... and that would be for ALL Professions
Page 15	Start the MFT statutes, Section 3 is being stricken because it is not necessary
Page 16	Standard reciprocity language "for 60 of the last 66 months"...
Page 17	Standard language for revocation, renewing and reinstating
Page 18	Need to strike old language and insert new language to refuse, deny or revoke a license
Page 19	KAPA proceeding, Section 13, insert "and if required by the Board" shall ...
Page 20	Section C – has been stricken and moved to page 28, Section F
Page 21-27	No changes

Page 28	Section F, language can be struck if Section G is added, Section H allows Master's degree can diagnose and treat while working on a training plan. May add another license type, such as Licensed Master's Addiction Counselor
Page 29	Insert standard new reciprocity language, Section C, strike "coursework" and insert "in a related field approved by the Board"
Page 30	Bottom of page, Insert standard language "shall pay", we want to insert " <u>if required by the Board</u> , shall pay"
Page 31	Insert standard new language to revoke, renew, reinstate, revoke...
Page 32	New Section B is the KAPA requirements, we can strike section 19 is we adopt Section B. Section 20 LP provisions are discussed, 3 rd line down insert " <u>If required by the Board</u> " for original license...
Page 33	Strike the language associated with the \$350 examination fee.
Page 34	Section A, insert standard reciprocity language " <u>for at least 60 of the last 66 months</u> " (b) Insert " <u>If required by the Board</u> " shall pay...
Page 35	Strike Section 1 so a person could take the exam 3 times before re-applying Bottom of page insert " <u>if required by the Board</u> " shall pay...
Page 36	First line, take out the word "post"
Page 37	Section 7, 2 nd line, "shall not exceed, <u>if required by the Board</u> ". Section 24 repealing the whole section.
Page 38	Section b, wording change to " <u>Shall submit the renewal</u> " because licensees can renew online, not just submit by paper. Last line concerns LPs... "current biennium of registration" Section d – new language, No more grace period for renewals.
Pages 39	Grounds to revoke, refuse to issue or reinstate, will insert new standard language and will also insert new standard language for reciprocity " <u>for at least 60 of the last 66 months</u> "
Pages 40 & 41	Section 27, administrative procedures (KAPA), Masters Level Psychologists- (27b) strike "10% points below..."

Page 43	Section F wording change from "permit" to "license"
Page 44	No changes
Page 45	Striking Section 2 at the bottom, Section c change "shall" to "may" on the top of page 46
Page 46 & 47	Grounds to revoke, renew, reinstate...insert standard new language
Page 48	KAPA language
Page 49	Reciprocity language inserted
Page 50	All professions' "ACT" need to spell out a "Social Work Licensure Act" instead of just statute numbers.
Page 51	Section 8 – is this complete enough language?
Page 52	Striking the language that is now in place.
*	Currently there is NO statutory language currently for LPC, MFT, and SW concerning supervisory Training requirements. We need to add this language.
**	Should we include any kind of DSM language in this? Or DSM language in a separate bill?
***	60 day grace period for renewals. Board agreed to this, so it needs to be added.
****	Addiction Counseling – The committee agreed to end the "Grandfathering" application and that date is July 1 st , 2016. The Board voted on this as well This information needs to be included.
*****	A degree in a "related-field" isn't necessary if all the required Addiction coursework is taken with another bachelor's degree program
*****	CRC – Marty Snyder and Whitney Casement
*****	Multiple licenses – give the authority to have all the licenses renew at the same time. Pull back and not award any extra time to the licenses.
