Behavioral Sciences Regulatory Board Social Work Advisory Committee Meeting March 16, 2021

Call to Order. The meeting was called to order by co-chair Carolyn Szafran at 1:00 p.m.

Guest Comments. Cheri Koochel, President of the Kansas School Social Work Association (KSSWA), discussed concerns regarding title protection for social workers.
