## JOURNAL ENTRY OF PARTIAL SATISFACTION

NOW ON THIS <u>27</u> day of April, 2022, the above captioned matter comes before the Kansas Behavioral Sciences Regulatory Board ("Board"), by and through the Chairperson of the Complaint Review Committee, a duly authorized representative of the Board, in accordance with K.S.A. 77-501, et seq., and upon due consideration of the agency record, applicable statutes and regulations, and being duly advised, makes the following determinations:

- 1. On or about September 14, 2021, Respondent entered into a Consent Agreement and Final Order ("2021 Consent Agreement") with the Board for violations of the Kansas Licensure of Psychologists Act, in Case No. 21-LP-0070.
- 2. However, Respondent failed to comply with the aforementioned 2021 Consent Agreement.
- 3. On or about March 17, 2022, the Board issued a Summary Proceeding Order ("2022 Summary Proceeding Order") that alleged Respondent may be in violation of the Kansas Licensure of Psychologists Act. Respondent did not request a hearing, and the 2022 Summary Proceeding Order became a Final Order on April 5, 2022.
- 4. On or about March 18, 2022, Respondent provided to the Board staff her proposed clinical-level supervisor as required by the terms and conditions of the 2021 Consent Agreement. Additionally, on March 29, 2022, Respondent provided to Board staff the release needed for her therapist to provide to the Board quarterly reports.

- 5. Following issuance of the 2022 Summary Proceeding Order, Respondent then complied with the terms and conditions of the 2021 Consent Agreement. Thus, the suspension ordered by the Summary Proceeding Order dated March 17, 2022, did not take effect.
- 6. However, the fine assessed against Respondent's LP license in the: 2022 Summary Proceeding Order remains due and owing.


