

STIPULATION

THIS AGREEMENT made and entered into this 17th day of December, 1985, by and between the KANSAS BEHAVIORAL SCIENCES REGULATORY BOARD(the Board) and Dr. Gary Hackney (the certificand).

WITNESSETH:

WHEREAS, ON February 11, 1985, the Board received a complaint about certain conduct of the certificand in his practice of psychology; and

WHEREAS, on June 29, 1985, the Board conducted an informal investigatory inquiry concerning the certificand's alleged violations of K.S.A. 74-5324(d) as defined by K.A.R. 102-1-10(b)(7) and 102-1-11(a)(9); and

WHEREAS, as a result of the informal investigatory inquiry, the Board found there to be probable casue to believe there had been conduct by the certificand which, pursuant to K.S.A. 74-5324 may result in revocation or suspension of certificand's license, and would warrant a formal hearing; and

WHEREAS, in lieu of the prosecution of charges at a formal hearing, the parties mutually desire to enter into a stipulation.

NOW THEREFORE in consideration of the forbearance of a formal adjudication proceeding and the other covenants and promises contained herein, the parties agree as follows:

1. That the certificand shall not take credit for work not personally performed;
2. That the certificand shall countersign all requests for payment for services performed by his uncertified assistant, if any;
3. That the certificand shall be supervised in his practice in psychology for the period of one year;
4. That such supervision shall be performed by Dr. Leslie Ruthven, 2601 East Central, Suite 1, Wichita, Kansas 67214;
5. That the certificand shall cooperate with the above-named supervisor to enable the supervisor to discharge his or her own duties in a responsible manner;
6. That the Board shall review quarterly reports from the certificand's supervisor;

7. That such reports shall reflect the certificand's satisfactory compliance with the Kansas statutes and administrative rules and regulations which govern the practice of psychology; and

8. That the certificand shall be responsible for all costs of such supervision.

This stipulation constitutes the entire agreement between the parties and may be modified or amended only by written instrument and signed by the parties. This stipulation shall take effect upon execution by the parties and shall remain in full force and effect until its automatic termination one year thereafter. In the event the certificand fails to meet any of the conditions of the stipulation, the stipulation at the option of the Board shall become null and void and the Board shall have the right to direct that formal charges be filed against the certificand.
