**CONSENT AGREEMENT AND ORDER**

Now on this 9 day of Sept 2000, the above-captioned matter comes before the Kansas Behavioral Sciences Regulatory Board, by agreement of Frederick D. Grossman and the Kansas Behavioral Sciences Regulatory Board (Board) for the purpose of settling the above-captioned matter.

Mr. Grossman acknowledges the following:

1. Licensee/Applicant is licensed as a masters level psychologist (LMLP) within the meaning of the Kansas Master Level Psychologists Act, K.S.A. 74-5361 *et seq*, and amendments thereto.
2. On September 14, 1998 the Board approved a Consent Agreement and Order that permitted Licensee/Applicant to continue practice as a masters level psychologist on specified terms and conditions for a period of 3 years from September 16, 1998.
3. The Consent Agreement and Order was based on the Board Investigative Consultant's determination that reasonable grounds existed to believe that Licensee/Applicant violated K.S.A. 74-5369(b), fraud in connection with the rendering of professional services, and K.S.A. 74-5369(d),

unprofessional conduct as defined by K.A.R. 102-4-5(b)(4), being convicted of a crime resulting from or relating to the registrant's professional practice of psychology, and by K.A.R. 102-4-5(b)(6), taking credit for work not personally performed.

4. To date Licensee/Applicant is in compliance with the terms and conditions of the Consent Agreement and Order.

5. On or about June 23, 2000 Licensee/Applicant submitted an application to the Board for transition from LMLP to licensed clinical psychotherapist (LCP).

6. Each of the indicated factual bases and corresponding legal grounds as set forth in the 1998 Consent Agreement and Order also provide a factual and legal rationale for the Board to deny a clinical psychotherapist license pursuant to K.S.A. 1999 Supp 74-5369(b) and (d), as amended by L. 1999, ch. 117, sec. 34.

HOWEVER, Licensee/Applicant and the Board mutually desire to enter into this Consent Agreement and Order in lieu of adjudicative proceedings to fully determine the issue of whether Licensee/Applicant should be denied a license. Licensee/Applicant would be entitled to such a hearing upon denial of his application by the Board.

Licensee/Applicant waives all rights to an adjudication of facts and law which could be determined pursuant to a hearing conducted in accordance with the Kansas administrative procedure act.

Licensee/Applicant waives the right to file a motion for reconsideration and all rights of appeal pursuant to the Kansas act for judicial review.

WHEREFORE, Licensee/Applicant hereby consents and agrees to the Board granting him clinical psychotherapist license on the conditions as specified in the 1998 Consent Agreement and

Order, which are hereby incorporated by reference, for a period of one (1) year from the date indicated in the below Certificate of Service.


Licensee/Applicant acknowledges that he has read this Consent Agreement and Order and fully understands and agrees to the contents.

WHEREFORE, Licensee/Applicant consents to the submission of this Consent Agreement and Order to the Kansas Behavioral Sciences Regulatory Board, and understands that upon approval of the Board, this Consent Agreement and Order becomes a Final Order of the Board.


