ORDER OF DISMISSAL WITH PREJUDICE

Being well and duly advised in the premises, the Presiding Officer finds that the following facts are not in dispute:

1. At all times relevant, Vivian L. Steavenson-Mundy was a Licensed Masters Social Worker within the meaning of the Kansas Social Workers Licensure Act, K.S.A. 63-6301, *et seq.*, and amendments thereto.

2. On April 20, 2010, in Lyon County District Court Case No. 09-CR-212, Licensee was convicted of five felony counts of Making a False Claim to Medicaid Program and one felony count of Obstruction of Medicaid Fraud Investigation.

3. The Lyon County District Court has ordered restitution exceeding \$158,000, which remains unpaid to date.

4. Respondent failed to report her felony convictions to the Kansas Behavioral Sciences Regulatory Board as required by statute.

5. The Board found that Respondent had not been sufficiently rehabilitated since the commission of the felony crimes to merit the public trust.

6. Based on those facts, the Board caused a Petition in Discipline to be filed, and an administrative disciplinary hearing on the Petition was set for February 18, 2011.

7. On February 17, 2011, Respondent, through counsel, wrote a letter to the Board surrendering her Kansas Licensed Masters Social Worker license [Exhibit A], and the Board, through counsel, accepted the surrender of the license effective immediately.

Therefore, the Presiding Officer finds that the Motion should be granted and the Petition should be and is hereby dismissed with prejudice, that the formal hearing on the Petition is canceled and that both parties shall bear their own costs in this matter.


