Questions on Professional Counseling Multi-State Compact

In 2023, Kansas passed HB 2288, which added Kansas to a multi-state compact for clinical-level professional counselors. Since that point, representatives from member-states have been meeting to determine the operating rules for the compact. It is anticipated that the compact will become operational sometime in 2025. Under this compact, clinical-level professional counselors (LCPCs) will need to maintain a permanent license in their home-state, but will have the option to obtain a "privilege to practice" in other compact member-states as an alternate to permanent licensure in those states, by paying a separate fee to each state in which they wish to practice. However, licensees could choose to maintain their out-of-state permanent licenses instead of seeking a privilege-to-practice.
