SUMMARY PROCEEDING ORDER

NOW on this <u>28</u> day of <u>March</u>, 2006, the above-captioned complaint comes before the Complaint Review Committee of the Kansas Behavioral Sciences Regulatory Board.

Findings of Fact

The Committee finds that the following facts have been established by clear and convincing evidence:

- Treasa Jo Cave (Licensee / Respondent) is a Licensed Baccalaureate
 Social Worker, License #6008, issued by the Kansas Behavioral Sciences
 Regulatory Board (Board / Petitioner).
- 2. At all times relevant, Licensee has been practicing as a Licensed Baccalaureate Social Worker within the meaning of the Kansas Social Workers Act, KSA 65-6301 *et seq.* and amendments thereto.
- 3. Licensee first received her LBSW license in August of 2001, with an expiration date of August of 2003.

- 4. Licensee failed to renew her license in August of 2003, and it expired.
- Licensee continued to practice as a LBSW at Larned State Hospital after her license had expired. Her employment was terminated in May of 2004 when it was discovered that she no longer had a license.
- 6. Licensee subsequently completed her CEUs and applied to the Board for reinstatement of her license. The license was reinstated in June of 2004.

Conclusions of Law

- 7. The Committee finds by clear and convincing evidence that the above facts constitute violations of KSA 65-6301, *et seq.*, as defined as follows.
- 8. The practice of social work without a current license is a violation of the Kansas Social Workers Act, specifically KSA 65-6311 concerning unprofessional conduct.

Sanction

Based on the above Findings of Fact and Conclusions of Law, the Committee, on behalf of the Kansas Behavioral Sciences Regulatory Board, finds that Treasa Jo Cave should receive a formal reprimand for failing to renew her license in a timely manner and for continuing to practice social work with an expired license.

IT IS SO ORDERED.
