## FINAL ORDER OF SUSPENSION OF LICENSE

Now on this 31<sup>ST</sup> day of October, 2007, the above referenced matter comes before the Behavioral Sciences Regulatory Board's Hearing Panel in relation to the September 8, 2007 Summary Proceeding Order that issued on September 12, 2007. The Hearing Panel is comprised of Board members Gary Price, Sharon Stuewe and Amory Lovin, assisted by Assistant Attorney General Camille Nohe serving as general counsel to the Hearing Panel. Petitioner appears by Assistant Attorney General Marty Snyder serving as disciplinary counsel on behalf of the Board's Complaint Review Committee. Respondent Angelina C. Gonzalez appears in person and by her attorney Pantaleon Florez.

Petitioner and Respondent present testimony, statements and arguments in support of their respective positions. Respondent further addresses questions posed by members of the Hearing Panel.

Petitioner's Exhibits C and D are admitted.

Following closing arguments, the Hearing Panel then deliberates in private, following which the Hearing Panel makes the following Findings of Fact, Conclusions of Law and Order.

# Findings of Fact and Conclusions of Law

- 1. On April 9, 2007, Respondent entered a Consent Agreement and Order in which she agreed to the following:
  - "(d) Licensee shall submit to the Board a five-page professional quality paper, APA format, on the care and treatment of social work clientele, professional responsibility and time management. The paper is due within sixty (60) days from the date shown on the Certificate of Service.
- The date shown on the Certificate of Service of the Consent Agreement and Order is April 9, 2007.
  - 3. The paper was thus due by June 8, 2007.
- 4. Respondent did not submit the paper by that date; nor has Respondent submitted the paper to date, although Respondent has prepared the paper and will submit it to the Board's Executive Director following close of the hearing.
- 5. In mitigation of not timely submitting the paper, Respondent had been working a full-time job at SRS and at the same time attempting to maintain her husband's bakery during the 4 months that he was incarcerated (approximately May through August 2007); consequently she was very stressed and frequently fatigued.
- 6. Additionally, adding to her stress was the fact that Respondent had not prepared any type of academic paper for 25 years, and thus was quite apprehensive about even beginning this task.
- 7. Nevertheless, in provision (i) of the Consent Agreement and Order, Respondent had acknowledged an affirmative duty to notify the Board of any changes in her personal status which would inhibit compliance with any condition of the Consent Agreement and

Order. In such event, a designee of the Board was authorized to modify and amend the Consent Agreement and Order in writing.

- 8. Respondent did not avail herself of this option.1
- 9. Respondent failed to comply with paragraph (d) of the Consent Agreement and Order, *i.e.*, that she submit to the Board a five-page professional quality paper, APA format, on the care and treatment of social work clientele, professional responsibility and time management within sixty (60) days from April 9, 2007.
- 10. In provision (f) of the Consent Agreement and Order, Respondent agreed that upon a determination at a hearing that she had failed to comply with any condition therein, her license would be suspended until such time as she could demonstrate compliance with the condition to the satisfaction of the Board.
- 11. On September 12, 2007, a Summary Proceeding Order issued on behalf of the Complaint Review Committee that suspended indefinitely Respondent's license until she can demonstrate compliance with the Consent Agreement and Order.

## Conclusions of Law

A. Pursuant to K.S.A. 77-537 and 77-542, the Summary Proceeding Order that issued on September 12, 2007 was subject to Respondent's request for a hearing within 15 days of the Order's issuance as stated in the Order's Notice of Relief.

B. The Notice of Relief contained the statement required by K.S.A. 77-537 that if a hearing is not timely requested, the Summary Proceeding Order becomes final and

effective upon expiration of the time for requesting a hearing and will become a Final Order

of the Board.

C. Respondent timely submitted a Request for Hearing, received in the Board's

office on September 28, 2007; thus, the Summary Proceeding Order did not become a

Final Order by operation of law, and Respondent continued to be licensed pending

outcome of the hearing.

D. Now, however, the Hearing Panel affirms the Summary Proceeding Order and

determines that Respondent is not in compliance with paragraph (d) of the Consent

Agreement and Order, i.e., that she submit to the Board a five-page professional quality

paper, APA format, on the care and treatment of social work clientele, professional

responsibility and time management within sixty (60) days from April 9, 2007.

E. Accordingly, the Hearing Panel issues the following final order.

<u>Order</u>

IT IS THEREFORE ORDERED that Respondent's LBSW License #1988 be and

hereby is suspended until such time as Respondent demonstrates compliance with

paragraph (d) of the Consent Agreement and Order, i.e., that Respondent submit to the

Board a five-page professional quality paper, APA format, on the care and treatment of

social work clientele, professional responsibility and time management which meets with

the satisfaction of the Board's Complaint Review Committee.

## **CONSENT AGREEMENT AND ORDER**

Licensee hereby acknowledges the following:

- 1. Angelina C. Gonzalez is currently, and at all times relevant has been, a Licensed Baccalaureate Social Worker within the meaning of the Kansas Social Workers Licensure Act, K.S.A. 65-6301 *et seq.*, and amendments thereto.
- 2. On or about July 18, 2005, the Board received a report of information concerning Licensee's conduct, alleging Licensee reported incomplete social work information, failed to make contact on assigned intakes, failed to make contact when a three-day response was required and practiced social work in an incompetent manner.

- 3. The Board conducted an investigation concerning Licensee's alleged violation of statutes and regulations.
- 4. During the investigation, Licensee was informed of the reported information, was given the opportunity to respond to the allegations and did respond to the allegations in her letter received on March 6, 2006.
- 5. As a result of the investigation, the Board finds probable cause to believe the following facts:
  - a. Licensee paperwork lacked adequate documentation,
  - b. Licensee failed to submit timely documentation, and
- c. Licensee neglected clients in need of professional care without making reasonable arrangements for that care.
- 6. The Board finds that reasonable grounds exist to believe Licensee has committed unprofessional conduct in violation of K.S.A. 65-6311(a)(4) and (6) as defined as follows:
  - a. K.A.R. 102-2-7(II) reporting ... incomplete ... social work information, and
- b. K.A.R. 102-2-7(nn) abandoning or neglecting a client under or in need of professional care without making reasonable arrangements for that care.

However, Licensee and the Board mutually desire to enter into a Consent Agreement and Order in lieu of adjudicative proceedings to resolve the report of alleged violations.

WHEREFORE, Licensee waives all rights to an adjudication of facts and law which could be determined pursuant to a hearing conducted in accordance with the Kansas Administrative Procedure Act in relation to Case No. 06- BS-06.

WHEREFORE, Licensee waives the right to file a motion for reconsideration and all rights of appeal pursuant to the Kansas Act for Judicial Review in Case No. 06-BS-06.

WHEREFORE, Licensee consents to continuation of her license to practice on the following terms, limitation and conditions:

- (a) Licensee shall not work in protective services with children or adults for a period of twelve (12) months from the date on the Certificate of Service.
- (b) If her current employment involves clinical practice requiring a social worker license, Licensee shall have twelve (12) months of supervised practice by a board-approved MSW supervisor who is not in a subordinate, familial or other dual relationship with the Licensee. The focus of the supervision shall be on the importance of completeness and timeliness in paperwork and documentation. There shall be at least one one-hour supervision session for each forty (40) hours worked.
- (c) The supervisor shall provide written progress reports to the Board every three (3) months regarding Licensee's compliance with the supervision process. In the event of non-compliance, the supervisor shall report to the Board immediately. Licensee shall provide the supervisor with a copy of this Consent Agreement and Order and shall make every effort to ensure that all conditions of the Agreement are met. Licensee shall cooperate with her supervisor to enable the supervisor to discharge these duties in a responsible manner.
- (d) Licensee shall submit to the Board a five-page professional quality paper, APA format, on the care and treatment of social work clientele, professional responsibility and time management. The paper is due within sixty (60) days from the date shown on the Certificate of Service.
- (e) Licensee shall be responsible for any costs and expenses incurred in satisfying the terms of this Consent Agreement and Order.

- (f) Evidence of Licensee's breach, violation or failure to comply with any of the conditions will result in a hearing, with notice and opportunity to be heard, to determine whether Licensee has in fact breached, violated or failed to comply with any conditions. Upon determination at such hearing that Licensee has breached, violated or failed to comply with any condition, Licensee understands and agrees that her license shall be suspended until such time as Licensee can demonstrate compliance with all terms and conditions of this Consent Agreement and Order to the satisfaction of the Board.
- (g) Licensee acknowledges that proof submitted to the Board by affidavit or other form of competent evidence that Licensee has breached, violated or failed to meet the conditions of this Consent Agreement and Order shall be good and sufficient evidence to support an alleged violation of breach, violation or non-compliance.
- (h) Licensee understands that a notification of this Consent Agreement and Order shall be provided to any other state licensing board if Licensee is also licensed, registered or certified in another state.
- (i) Licensee acknowledges an affirmative duty to notify the Board within five (5) days of any changes in personal or professional status which would inhibit compliance with any condition of this Consent Agreement and Order. In such event, a designee of the Board is authorized to modify or amend this Consent Agreement and Order in writing.
- (j) If the Board does not approve this Consent Agreement and Order, Licensee waives any right she may have to object to the composition of any subsequent hearing panel due to hearing panel members having knowledge of matters contained within this Consent Agreement and Order.

(k) This Consent Agreement and Order constitutes the entire agreement between

the Licensee and the Behavioral Sciences Regulatory Board and may be modified or

amended only by written agreement signed by Licensee and the Board or a designee of the

Board.

WHEREFORE, Licensee consents to the submission of this Consent Agreement and

Order to the Board's Complaint Review Committee and understands that, upon approval

of the Complaint Review Committee, this Consent Agreement and Order will become a

Final Order of the Board. The Board has authorized the Complaint Review Committee to

determine approval of this Consent Agreement and Order.

WHEREFORE, the Board agrees that, so long as Licensee complies with the above

conditions, the Board will not initiate further disciplinary action against Licensee in relation

to violations of K.S.A. 65-6311 as defined by K.A.R. 102-2-7 as a result of this proceeding.

WHEREFORE, the Board further agrees that, at the conclusion of the twelve-month

supervision period upon determination of Licensee's compliance with the conditions stated

herein and upon Board receipt of an acceptable reference from Licensee's supervisor on

a Board-approved form, Licensee shall be unconditionally licensed as a Licensed

Baccalaureate Social Worker.

WHEREFORE, the foregoing provisions are consented to, are hereby made the final

Order of the Kansas Behavioral Sciences Regulatory Board and become effective on the

date indicated in the Certificate of Service below.

## SUMMARY PROCEEDING ORDER

NOW on this \_\_\_\_\_ day of <u>September</u>, 2007, the above-captioned complaint comes before the Complaint Review Committee of the Kansas Behavioral Sciences Regulatory Board [Board].

## **Findings of Fact**

The Committee finds that the following findings of facts have been established by clear and convincing evidence:

- 1. Angelina C. Gonzalez is a Licensed Baccalaureate Social Worker, license #1988, which was issued by the Kansas Behavioral Sciences Regulatory Board.
- 2. At all times relevant to the complaint herein, Licensee was practicing as a Licensed Baccalaureate Social Worker within the meaning of the Kansas Social Workers Act, K.S.A. 65-6301 *et seg.* and amendments thereto.
  - 3. On or about April 4, 2007, Licensee executed a Consent Agreement and Order

in the above matter. Under the Order, Licensee consented to "continuation of her license to practice on the following terms, limitation and conditions:

- (a) Licensee shall not work in protective services with children or adults for a period of twelve (12) months from the date on the Certificate of Service.
- (b) If her current employment involves clinical practice requiring a social worker license, Licensee shall have twelve (12) months of supervised practice by a board-approved MSW supervisor who is not in a subordinate, familial or other dual relationship with the Licensee. The focus of the supervision shall be on the importance of completeness and timeliness in paperwork and documentation. There shall be at least one one-hour supervision session for each forty (40) hours worked.
- (c) The supervisor shall provide written progress reports to the Board every three (3) months regarding Licensee's compliance with the supervision process. In the event of non-compliance, the supervisor shall report to the Board immediately. Licensee shall provide the supervisor with a copy of this Consent Agreement and Order and shall make every effort to ensure that all conditions of the Agreement are met. Licensee shall cooperate with her supervisor to enable the supervisor to discharge these duties in a responsible manner.
- (d) Licensee shall submit to the Board a five-page professional quality paper, APA format, on the care and treatment of social work clientele, professional responsibility and time management. The paper is due within sixty (60) days from the date shown on the Certificate of Service.
- (e) Licensee shall be responsible for any costs and expenses incurred in satisfying the terms of this Consent Agreement and Order."

Because Licensee has not been employed in a setting where her license was required, the supervision element has not been in effect. However, compliance with term (d) above was required. The paper was due on or before June 8, 2007. Licensee has failed to honor the Agreement or comply with the Order, is now three months late and has made no arrangements to fulfill the terms of the Order.

### **Conclusions of Law**

The Kansas Administrative Procedure Act, K.S.A. 77-537 provides that a state agency may use summary proceedings, subject to a party's request for a hearing on the order, if the use of the proceedings in the circumstances does not violate any provision of law and the protection of the public interest does not require the state agency to give notice and an opportunity to participate to persons other than the parties.

#### Sanction

Based on the above Findings of Fact and Conclusions of Law, the Complaint Review Committee finds pursuant to K.S.A. 65-6311(a)(4) and K.S.A. 77-537 that the Kansas Baccalaureate Social Worker license of Angelina C. Gonzalez should be suspended indefinitely until she can demonstrate compliance with the Consent Agreement and Order and until further order of this Committee.
